

During the past year, I had been editing a friend's film titled [Triple Decker: A New England Love Story](#), in time for a preview screening at the Providence Public Library at 2 pm on Valentine's Day (Saturday, February 14th). The New England Triple-Decker house's history is a microcosm of the American urban experience, where a simple architectural form became a powerful symbol of immigration and community, fostering a sense of pride and shared identity. The building emerged from a specific set of circumstances, industrialization, immigration, and transit, as a brilliant and democratic solution to a housing crisis. There are essential echoes for today's housing crisis.



In other big news, a film I have been working on for almost 10 years, titled [Unbowed](#), will air on Rhode Island PBS in January. Log line for the film: Omar Bah was a young journalist, and because of his reporting, he had to flee The Gambia under threat of death from the regime's President. He is eventually resettled as a refugee in Rhode Island. When the same President is deposed years later, Omar is finally able to end his exile and claim much longed-for closure to this traumatic part of his life. As he prepares for his first return journey to The Gambia since exiled over a decade ago, the film reveals the remarkable person Omar has become in America.





Congratulations! [Shucking Tradition](#) has been selected for the 2026 SPE Media Festival in Atlanta. Congratulations! Shucking Tradition has been chosen for the La Femme Independent Film Festival London 2026. (These last two are the twelfth and thirteenth film festival wins for the Shucking Tradition film.)
